## **Marlene Thomas**

a. Letter sent to Attorney Bell for review of property at 36 Dutch Ave. Mark Bell did not like the letter Marlene Thomas drafted. Therefore, it will not be sent to the realtor. Marlene discussed the pig requirements and read the regulations. If we don't know acreage, we can pull this up from the county website.

b. Research on condemning properties-Marlene Thomas talked to the Brian Slade of the County Health Department. He stated we must have a letter or complaint that it is in a hazard and should be demolished. It is grandfathered in as far as setbacks go. They can only adjust the footprint by a small amount.

# Steve Oblad/Robyn Robbins

Procedures for Building Permits-Robyn Robbins checked out Eureka Utah's website and made a rough draft of some procedures. She would like everyone to read them and give their opinions and corrections. It was discussed about contractors having to wait to get their plans approved by the Planning Commission. Sometimes it is a whole month before they meet. It was suggested that Marlene look at the plans before sending them to Sunrise Engineering. Sunrise usually takes 5-10 days to approve them. The location of the buildings and the setbacks is the Planning Commission's biggest priority. Also we need to make sure the address is correct. It was suggested that now the weather is better, we should have another training outside, on sites with Kaye Hollien on how to assign an address.

### Vicki Nash

Updating of Stockton's General Plan- Vicki Nash has been reading the General Plan, but wants to go to the Land Use class to see if it will help in revising the plan. She will update us at the June Council Meeting.

## Joe Johnston

Stockton's Annexation Policy-Joe Johnston talked to three different people. Nando Meli worked on the old annexation plan and was at the meeting. When Nando Meli did the old one, he looked at lots of other cities. We need to make sure we have water, sewer, road upkeep, police and fire protection.
