4. Tooele County Sheriff Department-Sheriff Wimmer Three total details, no significant incidents.

5. Tom Daniels Utah DEQ update on OU2 update

Tom Daniels- Last year when the DEQ was out in Stockton they did some sampling, they dug trenches and test pits and found a layer of orange stuff that was about 6 inches thick. There was a lot of stuff that was found that was contaminated. Tom Daniels says it is a historic drain system from the Jacob Smelter. This stuff is very contaminated. Because this is such a significant change from what was originally proposed in the Record of Decision we have to do what's called an Explanation of Significant Differences. Tom has been working on this for about the past 4-5 months, hoping to have it finalized in the next couple months.

Others in attendance Jim Bori Karl Rhoads The DEQ is starting on our second phase of design which will take it up to where we bid out for a contract. The DEQ has enough money for that. Tom Daniels says we have to convince EPA to give us a grant to start the actual construction. We're hoping to have a contractor by April.

6. Mike Kennedy-Quantum Recovery Solutions

Mayor Karjola- Mike Kennedy is not here. He was the one who did our collections through Bonneville which is who we are currently using. He came by and brought this agreement. He has formed his own company, and wants to continue to have us as his customers. This is just about the same agreement that we had with Bonneville. I would like the Council to make motion to sign this agreement.

f. Water

There is less and less water coming off of the mountain, the generator that is running the well is not keeping up either. The water master said no outside watering until Saturday night (9/15/2018) so that we can recover the water tank. On Friday (9/14/2018) we will be posting notices at the Post Office and at the Town Hall.

Mayor Karjola- Spoke with John Iverson from Sunrise Engineering about the third pond. He said it is okay to let dry out for a few months during the summer.
