7. Department Reports

- a. Stockton Police Department-Chief Romney-See attached
Last month we had 32 traffic stops, 37 calls, 12 call outs, 04 county cases.

Use of force: On April 28, 2019 Stockton Police responded to a domestic in progress. After investigating, one male was arrested. He resisted arrest and a brief struggle with officers resulted. Control holds were applied to affect the arrest. A use of force report and investigation was completed and it was ruled that officers only used enough force as reasonably necessary to safely affect the arrest.

Major crimes: 1. Two domestic violence calls. 2. One possession of methamphetamine. 3. Five warrants. 4. One burglary. 5. One custodial interference.

Nuisances: Code 10-10-21: Recreation vehicles and mobile homes prohibited; exceptions-
Recreation vehicles: It shall be unlawful to place any recreation vehicle on any lot or parcel of land and to use the same for human habitation, except when located in a recreation vehicle court.

Community oriented policing: Chief Romney had the privilege of being requested to teach, interview and interrogation as well as victimology at the Police Academy that has recently started in Tooele County. There were half a dozen cadets in the first session.

- b. Stockton Fire Department-Chief Huffman/Assistant Chief Thatcher
Chief Huffman- Last month we had 9 calls, 2 of those were in Town.

The Fire Department has been getting all of the Wild Land Trucks worked on and getting them inspected. We had a few people in Regional Fire School at the Army Depot that finished.

We want to thank Tyler Bowden for working on some of our trucks, doing some minor repairs. It has saved the Fire Department a lot of time.

The Fire Department sent a truck out to Vernon to do a controlled burn on 300 acres last week. It was really good training. Our Wild Life Preparedness day was May 4, 2019 it went really well. We had a lot of support from the County, the Army Depot and the Chiefs Association.

We would like to thank Clark Hyde has donated hot dogs to the Fire Department twice and we would like him to be recognized for his donations.

Mayor Karjola- We had 5 baseball games on April 27, 2019. It turned out really well. All the teams enjoyed the ball field. Mayor Debbie Winn from Tooele City sang the National Anthem.
