Last month we had 55 traffic stops, 33 calls, 11 call outs, 03 County assists and no significant incidents.

Major Crimes- 1. One possession of methamphetamine. 2. Two family fights/ custodial interferences. 3. Two thefts.

Nuisances- We continue to receive complaints and are investigating/taking action on overgrown weeds.

Community oriented policing- Chief Romney, Elisa Canon and Ashlee Wanlass ran the Stockton Police booth at the Tooele County Annual Night Out Against Crime. The event was a success, we had a tremendously positive interaction with the various communities of Tooele County.

b. Stockton Fire Department-Chief Huffman/Assistant Chief Thatcher

Last month we had 24 calls 26% in Town, 8 medicals, 12 fires and 4 rescues.

Amy Lyman and Cory Jones went to Alabama Fire School for a week and they both passed their Hazmat courses.

There was a large fire in South Rim that burned over 358 acres. The fire was the first large incident for South Rim in over 10-15 years. The Fire Department had a post fire meeting and discussed fire prevention.
