a. Stockton Police Department-Chief Romney

Last month we had 51 traffic stops, 47 calls, 14 call outs and 02 County assists.

Use of force- 1. Intoxicated male resisting arrest had to use control holds to put him into cuffs and drug him to the Police vehicle. 2. Male State fugitive refused to stop for Stockton Police Officers, which then proceeded into a vehicle chase. He fled on foot and was apprehended into Tooele City. 3. Male smashed the rear end of his girlfriend's car. He was still holding the bat when Police Officers arrived, briefly had him at gun/Taser point and he dropped the bat. 4. Gas leak (included because we had to shut a neighborhood down for an hour).

Major crimes- 1. One drug case (shrooms) 2. Five warrants (2 were no bail warrants, fugitives from AP&P). 3. One high speed chase. 5. Five domestic violence's. 6. One child abuse.

Nuisances- 1. Barking dogs and strays (owners are being cited). 2. Two dogs were impounded, unknown owners and were put down.

Oriented policing- 1. Chief Travis Romney will be escorting the Easter Bunny around Town on Saturday April 11, 2020 at 10 am.

b. Stockton Fire Department-Chief Huffman/Assistant Chief Thatcher

The Fire Department is really slow during the spring time. The numbers of COVID-19 in the County haven't been bad. Keep the social distancing to 6 feet. Be sure to wash your hands for 20 seconds. Our pump needed replaced it was \$4,800. The Fire Department wants to make a purchase of \$10,000 out of Capital Funds for refurbishing an existing truck due to rust in the hoses. The Fire Department will have dumpsters available from April 16, 2020 to April 30, 2020 for the Town Residents to use.
