#### 7. Department Reports

a. Stockton Police Department-Chief Romney
Last month we had 38 traffic stops, 39 calls, 9 call outs and 2 County assists. There were no use of force incidents.

Major crimes: 1. Two drug possessions 2. One child pornography case 3. Three traffic stops with warrants 4. Two trespassing cases 5. One DUI 6. One stolen property case.

Ordinances: 1. Area 52 plan- The Police Department has been talking with Area 52 about taking lost dogs to their building until the owner is found instead of taking them to the Tooele Vet Clinic. Area 52 would not require any fee and would only ask that the Town purchase a dog kennel for the animals. The Tooele Vet Clinic only holds the animal for 7 days and then puts the animal down with a fee of \$150.00 every time the Police bring an animal to them. With making a contract and MOU with Area 52 we would be saving money and saving animals from being put down. 2. We are working with our Town Attorney to start the process on enforcing the cleaning of some of our troubled areas. The Police Department has issued a letter and the date it expires is on August 17, 2020 at 4:00 pm.

Community oriented policing: Cadet Micheal Canon is in his second week at the academy and Chief Romney is proud to report he is doing extremely well. POST may extend graduation week until right before Christmas because they are adding de-escalation training to the curriculum.

- b. Stockton Fire Department-Chief Huffman/Assistant Chief Thatcher Last month we had 16 calls, 9 fires, 2 rescues and 5 medical 18% in Town. It was talked about in last Town Council that The Fire Department wants to have a Fire Restrictions Ordinance. The Fire Department has been working on the feasibility study and is completed as a draft. This is something that has been in working progress for a few years now. The new brush truck is complete and just waiting for decals. The Fire Department has changed their rules of living in Town to be a volunteer on the Fire Department to living in a respond-able area to volunteer on the Fire Department. Since this change, there has been 4 inquires living in South Rim and Tooele County wanting to volunteer on the Fire Department.
