a. Stockton Police Department-Chief Romney

Last month we had a total of 31 calls. 1 agency assist, 1 animal, 5 drugs, 3 domestic violence, 2 fire assists, 1 fraud, 1 medical, 2 sex offense, 2 theft/car theft, 4 traffic accidents, 1 trespassing, 1 vagrant, 3 wanted persons/fugitive, 1 welfare check and 2 county assists.

-The last suspects in the homicide case from June plead guilty to manslaughter and felony distribution. We had a total of 6 arrests stemming from that case.

-The suspect in the rape and sexual abuse of a child case from August plead guilty and was sentenced to prison.

-Chief Romney has been working with Chief Huffman and the Tooele County Attorney. We are charging a 2nd degree felony theft of service for the \$12,000 stolen from the Fire Department.

b. Stockton Fire Department-Chief Huffman/Assistant Chief Thatcher

Last month we had 7 calls. The Fire Department has 2 students starting fire 1 fire 2. Amy Lyman is working on developing a policy and procedure for Businesses in the Town. The Fire Department is looking at spending \$12,000 for 12 SCBA bottles. We are sending 3 people to Winter Fire School this year.
