5. Department Reports

a. Stockton Police Department-Chief Romney

Last month we had a total of 41 calls, 47 traffic stops. 1 agency assist, 5 animal control, 1 burglary, 3 drugs, 1 domestic violence, 1 follow-up, 1 medical assist, 2 nuisance, 1 sex offense, 2 suspicious, 5 theft/car theft, 3 traffic accidents, 7 traffic offenses, 3 VIN inspections, 1 911 hang ups, 2 civil standbys and 2 citizen assists.

Our Stockton Police part-time officer has graduation phase 1 of FTO. He will be doing more Police work on his own with supervision.

b. Stockton Fire Department-Chief Huffman/Assistant Chief Thatcher

Last month was slow for the Fire Department. We had a total of 6 calls. The Fire Department got their money back for the SCBA Bottles. The Fire Department will have a rescue course in Spring this year, Chief Huffman will bring a presentation to the Council next month for more information on the rescue course.

6. Discussion on New Server

The Town needs a new server. The server we have is several years passed its live expectancy. We had an IT guy come out from Tooele City, he gave the Town some guidance on trying to get a new server.

7. Discussion on Repository Emergency Plan

The Jacob Smelter Superfund is contaminated with heavy metals in soils from smelting and mining activities. The contaminants of concern are lead and arsenic. This is located in to the West of Stockton and includes the Rawhide Subdivision.

The Stockton Repository is permitted and has the capacity to accept the 16,000 tons of non-hazardous soil being excavated. To accommodate the material, a third cell needs to be designed and constructed within the repository. The design, construction and oversight will be managed by the UDEQ.

UDEQ would like to propose a price for using the repository for the disposal of 16,000 tons of non-hazardous soil. Several factors will be considered when developing the price. UDEQ is willing and open to negotiating the cost of the use of the Stockton Repository; however, UDEQ is obligated to utilize the most cost-effective option for soil disposal.
